Vice President's Message By Mike Liane

I hope everyone is enjoying summer and looking forward to our annual convention in Carrington August 21-22. Bruce Willyard and his committee have been working hard to put together what is shaping up to be a terrific event.

It has been a very busy year for the Board of Directors. The legislative session, board changes and the Annual Fur Working Group Meeting with the Game and Fish have kept us on the go. The failure of SB 2146 was a huge disappointment to all of us who lobbied in favor of the bill. The ramifications of the loss to North Dakota trappers goes far beyond muskrat seasons. For the resident trapper the loss sets a serious precedence for the future. When Minnesota eventually gets reciprocity with North Dakota the rat bill will seem like a minor concern.

One of the most important efforts the board participates in annually is the Fur Working Group Meeting sponsored by the ND Game and Fish every spring. Several organizations with fur/predator control interests are invited to participate. And while this is not a policy making

group, this is the forum where issues of concern are brought forward for discussion. Several issues were identified by our board this year as a result of your responses on the member survey conducted last winter. Those of you that returned a survey can be assured that your voice was heard. I can tell you after having been involved in this process for several years that trappers have not fared well in this effort. Issues of concern brought forward by the trapping community have been greatly ignored by the powers to be with little or no progress. This has been extremely frustrating and left many questioning if it is worth our time and resources to continue participating.

I had the opportunity to share these frustrations with Game and Fish Director Terry Steinwand on one of many trips to the capitol during the legislative session last winter. Terry took notice and was receptive to our concerns which resulted in a much more productive working group meeting last May. For the first time we believed that

the Game and Fish representatives attending took our concerns seriously. We will reserve final judgment until the Furbearer Guide comes out in August, but we are optimistic that we have made progress. I hope to have time at our annual meeting in Carrington to give a brief overview of the issues we presented and any changes that resulted.

On another note, NDSU has recently completed the snare testing standards for the Game and Fish. These standards provide guidance to individuals inter-

ested in building an apparatus capable of testing release strength of breakaway devices. Final review of these standards is being completed at this time and the final version should be available very soon.

And finally, from my soapbox. North Dakota Fur Takers Association exists to support you in your trapping, snaring and hunting interests. This is where your concerns are heard. This is where your rights are defended. And there is strength in numbers. Every fur hunter/trapper in North Dakota should take this effort seriously. We need your continued

support, but we also need your help. I would like to ask every member to bring a friend and potential new member to our annual event in Carrington. Our agenda is printed in this newsletter and I believe it offers something for everyone. Come, spend the day, have some fun and maybe even go home with a new, useful technique.

I look forward to seeing you all in Carrington.

West Director's Report by Rick Wiege



NDFTA Board Meeting Minutes - March 22, 2015 Bismarck Public Library

Meeting called to order at 1:15 PM, by President, Gary Jepson. Board members in attendance: Dennis Kasowski, Rick Wiege, Joe Maertens, Bob Burns, Mike Liane, Tony Brandenburger, and Bruce Willyard. Secretary- Peggy Brandenburger. Also in attendance: Brent Kuss, and Rich Ackerman.

Motion made to dispense with reading of the Minutes and the Treasurer's report from the previous meeting by Tony Brandenburger, seconded by Rick Wiege. Motion carried.

Bruce Willyard reported on 2015 Fall Rendezvous preparations: Raffle tickets have been printed, rifles are always in stock so will not have to be ordered or paid for at this time, blanket has been ordered.

Gary Jepson reported on an opportunity for an additional raffle for a Commemorative Rifle valued at \$2,483.00. No interest by board members.

Bruce Willyard cites reason for board meeting is discussion of action to take after defeat of Muskrat Bill in the North Dakota House of Representatives when it passed easily in the Senate. This issue resulted in a majority of board members and officers to ask for Gary Jepson's resignation as President.

Gary Jepson states several county commissioners, a few Fur Taker members, Game and Fish, and the House Natural Resource Committee not in favor of Bill.

Lobbyists Bruce Willyard and Mike Liane report that their mission to support the passage of the Muskrat Bill (confirmed by a majority vote of Fur Takers General Membership at the 2014 Fall Rendezvous meeting) was not shared by lobbyist Gary Jepson, and that he did not lobby for the Bill.

Gary agrees he was against the Bill.

Brent Kuss and Rich Ackerman address the board first thanking Gary for his contributions to the organization and personally mentoring them, then citing why they feel that Gary Jepson no longer fully represents the interests of the organization.

Mike Liane reports on the results of the North Dakota Fur Takers Member Survey that was sent out to about 80 members with the last newsletter, 20 were returned.

Bruce Willyard presented a "ND Fur Takers Education" booklet that was printed in 1997. A good educational resource to promote fur harvest. Will decide at next General Membership meeting if new updated booklet should be printed.

Mike Liane reports that Web site will be updated. He is also compiling a list of discussion topics for the Fur Working Group Meeting, will have to send 2 or 3 people.

Bruce Willyard reports on Fall Rendezvous demos, and plans for a youth pellet gun contest.

Resignation tendered by President Gary Jepson, he leaves meeting at 4:00.

Mike Liane opens discussion on how to move ahead to fill vacancy of President. Consensus of board that the position will remain open until 2015 Fall Rendezvous, an election committee will be formed to obtain suitable candidates.

Discussion of Hall of Fame meeting May 2nd in Belfield. Make-a-Wish people will be there.

Discussion on reimbursement of expenses for travel to Board meetings. Payment will be made if individuals present a bill.

Meeting adjourned 4:40.
